

## CONSENT TO PERSONAL DATA PROCESSING

This consent to personal data processing constitutes a public offer.

While making a reservation for a room, a natural person shall accept this Consent to personal data processing (hereinafter referred to as the Consent).

The User hereby gives his/her consent to Hotel complex "Lotus" LLC, located at the following address 9 Plekhanovskaya street, Voronezh, 394018, Russia (hereinafter referred to as the Operator), to his/her personal data processing on the following conditions:

1. This Consent is given for personal data processing executed with or without the use of automation means.

2. This Consent is given for processing of the following personal data:

Personal information that does not constitute special or biometric data: last name, first name, patronymic; phone numbers; email addresses; information about social network accounts; sex; age; information about the purchased goods and services; location data.

3. The personal data shall not be generally available.

4. The aim of such personal data processing shall be: Compliance with the requirements of the Constitution of the Russian Federation, federal laws, and other internal regulations; reservation of rooms and locations for execution of events at the company hotels engaged in the business under the Azimut Hotels brand.

5. The grounds for the personal data processing shall be as follows: Art. 24 of the Constitution of the Russian Federation; Federal law of 27.07.2006 №152-FZ «Of personal data»; Articles of Association of the Operator; RF government regulation of 09.10.2015 № 1085 «On approval of the rules for provision of hotel services in the Russian Federation»; this offer.

6. During personal data processing, the following actions shall be performed: collection; record; filing; accumulation; storage; adjustment (update, amendment); extraction; use; transfer (distribution, submission, access); blocking; removal; destruction.

7. In order to execute this public offer, the personal data shall be transferred to the following third parties: AZIMUT Hotels Company, LLC (address: 129110, city of Moscow, Olimpiyskiy prospekt, 18/1), TravelCLICK, Inc. (address: 38th floor, 7 Times Square, New York, New York, 10036, USA) in order to process the personal data mentioned in clause 4 of this Consent; the list of personal data shall correspond to clause 2 of this Consent; the list of actions performed with the personal data shall correspond to clause 6 of this Consent.

8. In order to accomplish the aims mentioned in clause 4 of this Consent, the personal data can be sent trans-border to Germany, Austria, as well as to the USA, without provision of an adequate defense of rights of the personal data subjects.

9. This Consent shall come into force when signed and shall remain in force while the natural person remains under the effect of the Consent.

10. This Consent can be recalled by the personal data subject or his/her representative by sending a written application to the Operator or his/her representative, to the address mentioned at the beginning of this Consent.

11. In case the personal data subject or his/her representative recalls this consent to personal data processing, the Operator shall have the right to continue processing of the personal data without the personal data subject's consent in the presence of the grounds mentioned in clauses 2 – 11 of part 1, article 6, part 2, article 10 and part 2, article 11 of Federal law №152-FZ «On personal data» of 27.07.2006.

12. This consent shall be valid at all times until termination of processing of the personal data mentioned in clauses 9 and 10 of this Consent.
